Facility Description

The Seneca Station is a natural gas transmission facility covered by Standard Industrial Classification (SIC) 4922. The station has the potential to operate seven (7) days per week, twenty-four (24) hours per day. The station consists of one (1) 13,750 hp, two (2) 7,491 hp, one (1) 1,557 hp, one (1) 15,432 hp, and one (1) 10,613 hp natural gas fired turbine engines, one (1) emergency generator, two (2) fuel gas heaters, one (1) process heater, catalytic space heaters and fourteen (14) storage tanks of various sizes.

Emissions Summary

There are no changes in emissions resulting from this modification.

Title V Program Applicability Basis

With the proposed changes associated with this modification, this facility maintains the potential to emit 314.52 tons/yr of NO_x and 371.97 tons/yr of CO. Due to this facility's potential to emit over 100 tons per year of criteria pollutant, Columbia Gas Transmission, LLC's Seneca Compressor Station is required to have an operating permit pursuant to Title V of the Federal Clean Air Act as amended and 45CSR30.

Legal and Factual Basis for Permit Conditions

The State and Federally-enforceable conditions of the Title V Operating Permits are based upon the requirements of the State of West Virginia Operating Permit Rule 45CSR30 for the purposes of Title V of the Federal Clean Air Act and the underlying applicable requirements in other state and federal rules.

The modification to this facility has been found to be subject to the following applicable rules:

Determinations and Justifications

The revisions made in association with this minor modification incorporate the revisions made in R13-2715H Class I Administrative Update which revises the turbine CO testing requirement and makes other minor administrative changes. The revisions to the Title V permit include the following:

- 1) **Section 1.1. Emission Units Table** In the Emission Unit Description column, revised the description of Emission Units 03705, 03706, 03707, and 03708 by removing "-7800S, -7800S, -1400 and -15000S" respectively. Also removed the number of space heaters in the descriptions for 037SH1 and 037SH2.
- 2) Section 1.2. Active R13, R14, and R19 Permits Table Updated R13-2715G to R13-2715H and updated the date of issue.

3) Section 4.0.

As described in the changes to the emission units table, the additional turbine descriptions of "-7800S, -7800S, -1400 and -15000S" have been removed from permit conditions 4.1.1., 4.1.2., 4.1.4., 4.1.6. and 4.1.8. Also, permit R13-2715H deleted two permit conditions and renumbered the existing conditions. Therefore, where appropriate, the COAs in several of the Title V permit conditions in this section have been revised. No further discussion will be made concerning these revisions. Other specific revisions include the following:

- ➤ Condition 4.1.3. These requirements have been deleted in R13-2715H and therefore have been deleted from the Title V permit and replaced with "Reserved."
- ➤ Condition 4.1.7. These requirements have been deleted in R13-2715H and therefore have been deleted from the Title V permit and replaced with "Reserved."
- Condition 4.1.9. Added "RICE" to the description of Generator G3.
- ➤ Condition 4.1.12. Revised as revised in R13-2715H
- ➤ Condition 4.3.1. Revised as revised in R13-2715H
- ➤ Condition 4.4.3. These requirements have been deleted in R13-2715H and therefore have been deleted from the Title V permit and replaced with "Reserved."
- ➤ Condition 4.4.6. Except for the revised COA, the revisions to this condition were not part of the R13-2715H revisions or the minor modification application. The revisions are to correct typographical errors by revising "PT" to "P_T" and "Px" to "P_T" as they appear in R13-2715H.
- ➤ Condition 4.5.2. These requirements have been deleted in R13-2715H and therefore have been deleted from the Title V permit and replaced with "Reserved."

4) Section 5.0.

- Condition 5.1.1. Added "RICE" to the description of Generator G3 and revised the COA.
- ➤ Condition 5.2.1. Revised the COA.

5) Section 6.0.

- ➤ Conditions 6.1.1. and 6.1.2. Added "100" to the description of the Solar Mars Turbine (E08) and revised the COAs.
- ➤ Conditions 6.1.5. and 6.2.1. Revised the COAs.
